PROPERTIES

- Miriam Jackson
 - o Maria and Barbara presented finished plans for the three gardens to the board. They discussed possible use of rain barrels with an irrigation line for watering, and asking the town to keep the barrels full, but did not have a cost estimate for the materials yet. They are hoping to reuse rain barrels that has been used at the Library.
 - o Maria was also asking for milk jugs to start planting the seeds in.
 - o Liz asked if they will need potting soil, Barbara said they will.
 - o Scott asked if there's anything that can be done to stop the ants from eating the monarch eggs, Barbara said she'd look into it.
 - o Barbara is also looking into getting free lilac plants from the state nursery.
 - o Barbara gave Maria lots of praise for the work she's done on this project.

- o Barbara said she might ask for help as spring gets closer to help get materials down to the park.
- Updated land data
 - o Liz said updated maps would be about \$500.
 - o From the email:
 - In 2021, it would be 4794.75 Acres conserved for 28.8%.
 - The amount of acres where Epping is listed as the Primary Protection is approx. 665 in 2021.
 - o Gabe asked about goals for total percentage of land conserved, but there is no current goal.
 - o Ongoing discussion about what can and can't be done with the data
 - o Liz will get clarification on what the \$500 can get us.
 - o Suggesting holding off for Joe to get more information about when the town will complete their tax map update

 - o Dan received the invoice for the table and was paid out of the 2022 budget. Unsure of ETA for the table.
