Introduction of Daphne Thurston who is interested in possibly joining the Commission, potentially as an alternate.

### **Permits**

Clever Lion – Commercial Project 125/Fogg Rd. (Jones and Beach)

- Barry Gier from Jones and Beach presented a project for a restaurant and retail building on the southwest corner of Fogg Rd and Rt 125.
- Project has been submitted to planning board and is going to zoning board shortly
- Conditional use permit is for wetland buffer impact. There is no wetland impact.
- The areas in the buffer would be a dumpster pad and the retention pond.
- Ongoing discussion regarding the project and plans.
- Joe T shared his opinion that he doesn't believe the lot supports a building of this size.
- Scott does not have any issues with the plan as proposed. He commends them on not having any pavement in the buffer, and stated that the wetland itself is not a high value wetland.
- Liz would like to make a recommendation to the planning board to require daily inspections to ensure the wetland is not disturbed.

• Scott made a motion to not object to the plan as presented, with the condition that the silt fence is pulled 3 ft back from the wetland line, and daily inspection of erosion controls along the length of the proposed basin during construction. Liz seconded. Motion passed.

Shirking Rd. – Commercial Site Plan for Self Storage (Jones and Beach)

- Joe Coronati from Jones and Beach presenting
- Already conditionally approved by the planning board
- This lot is on the corner of Shirkin Rd and Martin Rd.
- Scott made a motion to not object to the plan as presented, with the condition that the silt fence is pulled 3 ft back from the wetland line, and daily inspection of erosion controls along the length of the proposed basin during construction. Ben seconded. Motion passed.
  - Liz noted that the daily inspection could be performed by the site super.

Sig Sauer – 300 Meter Range (Jones and Beach)

- Joe Coronati presenting a conceptual plan
- Joe said they are looking to build a 300 meter long indoor range. The majority of the building is only 15 ft wide.
- Joe recommended a site walk, possibly with the planning board. He hopes to meet with the planning board at their next meeting.

44 Prescott Rd. - Informational Question on Man Made Pond (Jones and Beach)

- Joe had a question about man made ponds.
- Joe questioned if there is a setback for structures to a man made pond if it's built in uplands.
- Scott stated that if the man made feature becomes a wetland after it's built, then it would be subject to wetland rules.

## Budget

- Liz made a motion to request \$6,000 as our operating budget for next year. Dan seconded. Motion passed.
